## WHY THE “SWGP BUS TOUR ACROSS AMERICA?”



Dear Brothers,

Not a day has been lost in evaluating our new and regulated University environment, best practices of the top performing fraternities, and adjusting our vision, strategy and resources to live up to the values in Phi Kappa Psi. As a business professional and heavily involved brother, when I stepped into the SWGP role, it was disappointing to discover our many shortfalls at National Headquarters.

We have now built a smart and thoughtful plan and continue to implement much needed change. It will appear grand and unsustainable, when in fact no less than ten leading fraternities are already 5-10 years into elevated standards, exceptional customer service, high-impact programming and proven outcomes. We will accomplish the same level of reform within 2-3 years; mostly out of necessity.

The University environment and expectations have indeed changed and we ask you to give us an opportunity to share these new developments in person. We have built a wonderful presentation and are providing an open forum to have an engaged discussion about our vision and resources. We seek to fully understand your university culture, alumni, and chapter leadership. The combination of knowledge transfer and trust will build a special and sustainable home for the undergraduate members of Phi Kappa Psi.

We need you to avoid ever sitting on the sidelines again. Please give your time, your advice and your finances each and every year. Trust this brotherhood to counsel young boys into honorable men.

The SWGP Bus Tour is a series of stops across the United States, beginning on the West Coast and moving East, finishing up at GAC in New York City. It is an opportunity for us to present to you the new attitude of the Phi Kappa Psi Headquarters and a variety of resources internally or outsourced to achieve your desired local results.

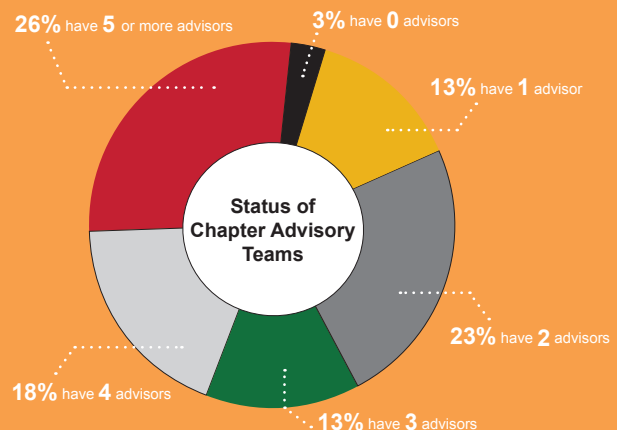

## INTRODUCING MIKE D'ARCANGELO AN IDEAL FACULTY ADVISOR

---

The faculty advisor position is a nebulous concept in most chapters. Some have them, some utilize them, some have never heard of them, and others have one on the roster without any idea as to their purpose or function.

Far too often, a chapter recruits a faculty advisor from the faculty or staff pool on campus based on some kind of personal connection. The advisor signs the papers, steps into the role, and begins their term as the acting faculty advisor. However, what usually happens is the unfortunate reality most of our chapters experience: inactivity of the position and a lack of mutual expectations. The ideal role of a faculty advisor is unfamiliar to most of our undergraduates, resulting in a transactional relationship that benefits very few involved. Luckily, we have a prime example of how to manage the faculty advisor relationship with professionalism and intentionality. That example comes from our NY Theta chapter at the Rochester Institute of Technology (RIT).



# FACULTY ADVISOR ROLE

Affectionately known as 'Mike D' to NY Thetans, Mike D'Arcangelo currently serves RIT as the Director of Diversity Education and has been the faculty advisor for the NY Theta chapter for eight years. His resume of accomplishments as an advisor and professional is impressive: he advised three separate Outstanding Greek Chapter award winners (2009, 2011, 2012), he was named Outstanding Greek Advisor in 2011, he re-started the Phi Kappa Phi chapter at RIT, and received numerous awards for his professional accomplishments throughout the years. He possesses a Master's Degree in Human Resources from RIT and a Ph.D. in Higher Education from State University of New York - Buffalo State. Our organization is lucky to have him as a full supporter.

D'Arcangelo's involvement with fraternities began well before his involvement with the men of NY Theta. Mike is a member of the Theta Chi Fraternity, initiated at Westminster College in New Wilmington, PA. His chapter was around 100 men and he was part of a new member class of about 33.

"The Fraternity at Westminster became a second home for me. My parents divorced while I was in college and Theta Chi became a refuge that I desperately needed. My connection with my brothers is something I still value today," said D'Arcangelo.

After a very meaningful undergraduate experience, D'Arcangelo went on to pursue a career in academics and student affairs at RIT. He began as the Associate Director of Campus Life at RIT in 1989, eventually moving into a role as the Director of the Center for Campus Life and an adjunct professor about four years later. Since then, he has served in various capacities, working with students in diversity education, student government, and fraternities/sororities, along with human resources consulting and instructional designer in the private realm.

D'Arcangelo was first introduced to the Phi Kappa Psi Fraternity while he was at Washington & Jefferson College. He became involved with the PA Alpha chapter and found the experience to be very rewarding. With that first impression in the bag, he made a professional transition to Ashland University in Ashland, OH. While there, he found himself at another college with a Phi Psi chapter.

"At the time, I was a Greek advisor attempting to rebuild the community and I had very pleasant experiences with Phi Kappa Psi," said D'Arcangelo.

After moving into student activities at RIT, his office helped to organize the expansion of Phi Kappa Psi where he was periodically exposed to the founding fathers and their purpose. As the years progressed, his office was also responsible hiring a number of Phi Psi's into student leadership and worker positions; this was his first real exposure to the men of NY Theta. He was first offered



the faculty advisor role while he was pursuing his Ph.D.—which he had to turn down for time management reasons. In the summer of 2007, the advisor for NY Theta left his role and once again, the chapter asked him to be involved. At that point, D'Arcangelo was wrapping up his Ph.D. work and no longer had a reason to say no; it was the right time to get involved. Eight years have passed since then and he has made a difference in the lives of hundreds of Phi Psis who have entered the rolls.

## EVERYDAY RESPONSIBILITIES OF THE ROLE

Since being appointed as faculty advisor, D'Arcangelo has flourished in his relationship with the men of NY Theta. The chapter respects D'Arcangelo for his guidance and mentoring approach to the role, while also recognizing him as a friend of the Fraternity.

"The most enjoyable aspect of the position is the privilege I receive of watching these young men mature each and every day. They take their obligations very seriously, but they are also a lot of fun and they can be quite humorous at times," said D'Arcangelo.

Despite incredible success, the role of a faculty advisor doesn't exist without its challenges. D'Arcangelo strongly believes his biggest obstacles in the role have been getting to know as many members as possible and garnering acceptance from new members. With new members always coming into the chapter, those challenges are an unavoidable constant.

Several brothers of the NY Theta Chapter shared their experiences of working with D'Arcangelo:

"Mike D. has made a tremendous impact on my life. When I was thinking about running for Student Government President, he casually said 'They need a guy like you in that position, you'd be perfect for that.' He probably doesn't even remember saying that but it was one of the reasons I decided to run and I can never thank him enough for that." – Taylor Deer (RIT '08)

"I appreciate Mike's ability to effortlessly make everyone around him better. He takes being an advisor to a new level; not only does he care about the fraternity as a whole, he genuinely cares about every single member." – Danny Malcaus (*RIT '11*)

"Mike D is much more than an advisor. His mentoring of older and younger brothers alike is something that your everyday faculty advisor will not take the time to do. Mike D will also inspire you to challenge and push your limits as a person and a member of Phi Psi. His impact on the chapter cannot be measured; he truly is a selfless individual that gives his all to a Greek organization other than his own."

## RECOMMENDATIONS ON BEING A SUCCESSFUL FACULTY ADVISOR

Given his long career of success as a faculty advisor, D'Arcangelo has learned through experience what works and what doesn't. His recommendations for a fruitful chapter and faculty advisor experience:

- From the outset, define the expectations and goals of the relationship. What does the chapter want/need from the faculty advisor? How much time does the potential faculty advisor have to give? Be sure these expectations are clear and agreed upon by both sides.
- As a faculty advisor steps into the role, they need to do an assessment of the needs of the students and the chapter. What do they really need? Is that the same as their vocalized needs? That will drive a majority of the involvement.
- Fill an unmet role (this will be easier after a thorough assessment of the chapter culture). This could mean attending specific trainings on or off campus to help be a resource in this unmet area of need.
- Stay relevant with the issues and topics facing college students on and off campus. This knowledge is important for keeping things in perspective in conversations.
- Make it a priority to challenge the thought process of the undergraduates. As one of the few "older" adults in the room, undergraduates need advisors who can propose healthy alternatives to their thought process. It challenges them to think through situations completely and to create better outcomes.

Thank you, Mike, for all of your hard work and dedication to Phi Kappa Psi. We hope your example serves as a framework for how to amplify the involvement of other faculty advisors in our chapters. ■







## VOLUNTEER SPOTLIGHT

Amici Brothers,

I am writing this to encourage you to step up and make a difference in the lives of our undergrad brothers. Do you have a little bit of time to spare to help advise or mentor a chapter? The rewards are great.

I myself have been a chapter advisor for over 4 years now. I, like many of us, walked away from the Fraternity after becoming an alumnus. I had nothing to do with the Fraternity for 15 years outside of keeping in touch with my small group of chapter brothers. After having to close our chapter, there was nothing really left for me. I am one of the last Illinois Betans.

I grew up in San Diego, and when I moved back to make it my permanent home again, I too fell into the trap of thinking the local chapter wasn't my chapter and was not interested in affiliating with them. Long story, short: I have to

admit I was roped into becoming an advisor. I'm not sure I would have done it voluntarily on my own because I never thought I had what it takes to do such a thing. Now I question myself as to why I wouldn't have. The culture of the chapter could not have been more opposite from what I experienced in my own chapter. You know what? That fact actually made becoming an advisor even more enjoyable. It gave me a great creative challenge to adapt and mentor. The chapter I am advising had 20 members when I became involved. Through their leadership, dedication and insight from me, we are now almost 130 men strong.



Many of us in business have enjoyed and or wanted the opportunity to start something. Here is a perfect opportunity to be able to do that. Chapters are small businesses and the thrill of watching your own enterprise grow and flourish under your tutelage can be just

as exciting as if it were your own personal business. The undergrad brothers, I have found, have gained confidence and savvy because they know an older brother is out there for them to reach out to. I cannot emphasize this enough. Even though when I could not be as active as I wanted with them at various points in time, they knew I was there and that help to keep their confidence and drive alive.

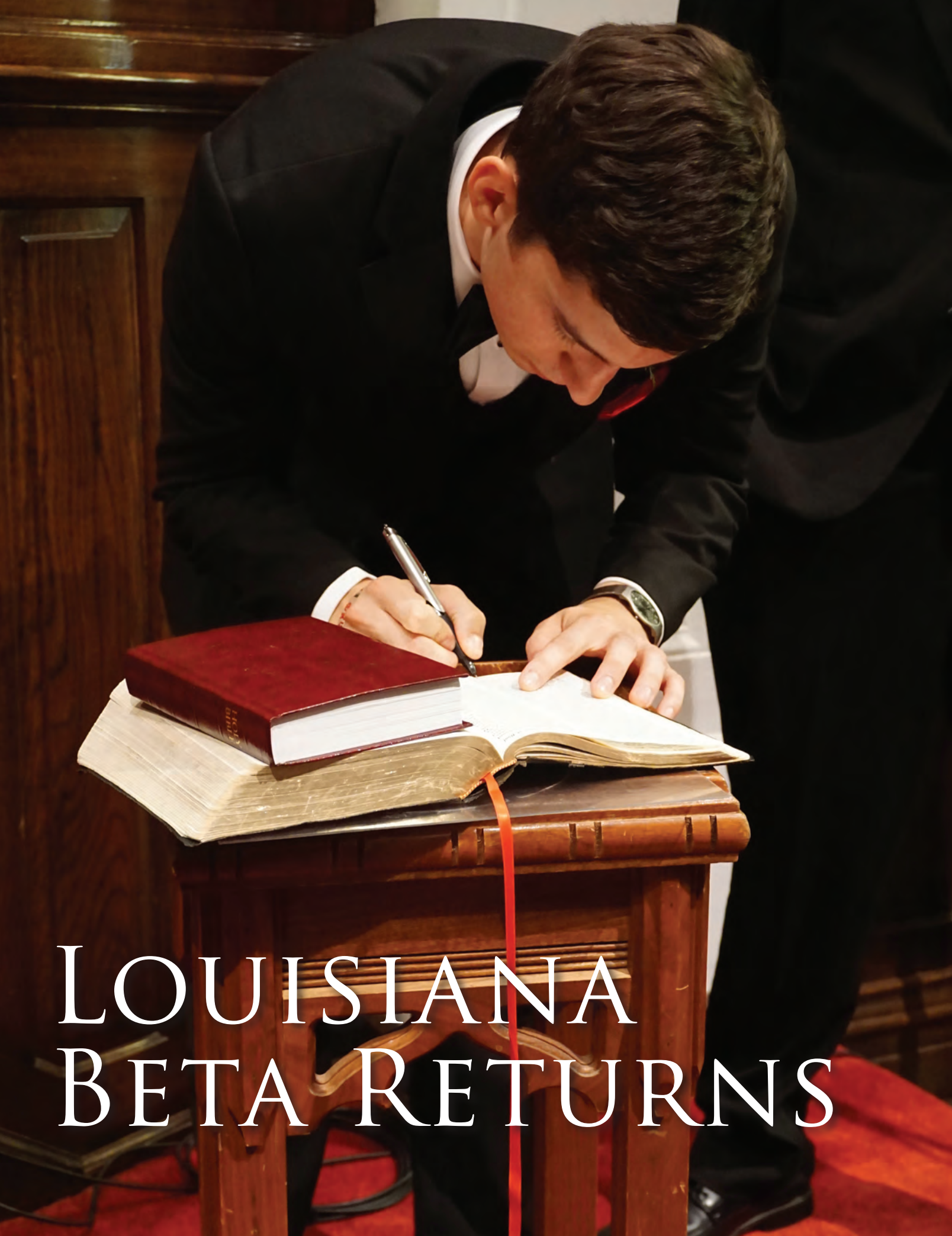

# LOUISIANA BETA RETURNS



The Phi Kappa Psi Fraternity grew a little bigger as it celebrated the return of the Louisiana Beta Chapter to the University of Louisiana at Lafayette in October. The chapter was initiated with 31 new members.

Originally chartered in 1969, the LA Beta chapter was forced to disband in 1991 due to campus-wide low recruitment numbers. Gone, but not forgotten, the LA Beta alumni continued to maintain a presence in the national Fraternity and worked with the University and the Fraternity to develop a timeline to return to campus.

After the formation of the South Central Louisiana Alumni Association as a base of alumni for support, and approval from the University, the stage was finally set for the formation of a colony on campus in the spring of 2013.

On hand for this celebration were members of the Phi Psi Executive Council, Alumni from the original chartering, University officials, and members of Headquarters staff. The weekend began with a campus tour on Friday afternoon (including a tour of the new Student Union, the brand new Athletic complex, and the Colony (now Chapter) House. Friday night also included a reception in the new Student Union, followed by the first section of Initiation. Saturday morning began early with the completion of the Initiation Ceremony at the First United Methodist Church in downtown Lafayette, followed that evening by the Chartering Banquet.

A few brothers shared their thoughts on the rechartering.

"I was active in the LA Beta chapter from 1978 until my graduation in 1982. When I joined, our chapter was young, only 10 years old at the time. It was also at a time when we were at our strongest. We had dedicated brothers who work hard to maintain the standards of Phi Psi. Many fraternities had a decline in membership including Phi Psi and HQ decided to close the chapter in about 1991.

Despite the closing of the chapter, many of the alumni maintained a strong connection as we continued to hold Phi Psi events over the years. In about 2008 Brother Will Haskett visited one of our reunion events and recognized the brotherhood bond we still had at LA Beta and felt we were in a position to bring LA Beta back on campus. In the years that followed we formed a new Alumni association and gained support of many LA Beta brothers and other area alumni. We worked many hours towards bring LA Beta back on campus at UL Lafayette.

As the Colony was official formed, one of our alumni step up to purchase a house to use as a chapter house. Our House Corporation has been organized and we are currently in the process of finalizing the deal to purchase the house from him. LA Beta brothers have pledged and donated the resources to make this deal a reality. Now that we are officially a chapter again, Brothers continue to step up to offer assistance and help as needed to maintain and build the chapter. I never gave up on the dream of having our chapter back on campus, today it is a reality and looking forward to many years of growth and progress for the LA Beta Chapter."

# COMMON SENSE IS NOW A SUPER POWER



## FINDING SOLUTIONS TO THE 148-YEAR-OLD HAZING PROBLEM

I have Google Alerts set for various news stories. “Frat and Hazing” is one such setting. At least once a week a story pings to my email. My first reaction is always, “Please don’t be us, please don’t be us.” After determining whether it is us or not, I immediately feel for my counterpart at the other fraternity. Sadly, all too often, the news story is about us and we have to deal with the ramifications.

Shooting new members with tazers; forcing new members to drink with their elbows sitting on beer bottle caps until the bottle caps filled with blood; locking new members in dog cages and making them eat out of bowls are three incidents, during this biennium, where sadly the hazing incident came from our chapters.

Hazing is not new. Our fraternity has been dealing with this issue since the 1868 Cincinnati, OH GAC. Returning Civil War Veterans apparently were taking liberties with new members, and giving them what is described in our

archives as ‘the treatment’. It was noted at that GAC, “...the elimination of hazing and informal initiations has been a continuing problem, and its final solution has not yet been found. Phi Kappa Psi has taken an unequivocal stand in these matters, and by the substitution of other activities has been notably successful in driving out these insidious practices. How incongruous it would be to paddle a man on Thursday, initiate him, and call him ‘Brother’ on Friday! The word ‘Brother’, which has always meant so much to all who are Phi Psis, would mean little to him at that precise moment when it should never be more meaningful.”

Our fraternity is still trying to tackle this issue. We took the following actions at the 2014 GAC: We passed an amendment to our bylaws expanding the definition of hazing to include violations of federal, state and university laws.



Additionally, past SWGP, Tryon Hubbard, *Alabama '64*, made the following resolution, which passed unanimously:

"The 2014 Grand Arch Council strongly condemns hazing in any form. The Grand Arch Council urges the Executive Council to devote every single resource at its disposal to the eradication of this singularly un-fraternal practice.

Further, this Grand Arch Council directs the Executive Council to report to the 2016 Grand Arch Council the specific actions taken to reduce hazing including, but not limited to, education of our members, early intervention in potential hazing, and punishment of those responsible for any hazing that may occur."

The Executive Council has taken these marching orders very seriously, and has worked extensively to try to find solutions to this 148-year-old problem.

So, what has been done? First, three men have been removed from our rolls as brothers for their roles in hazing incidents at the West Virginia Alpha chapter. The fraternity cooperated with the criminal investigation and prosecution of these men, all of whom received jail sentences for their hazing actions.

From an educational standpoint, all undergraduate members are required to complete Greek Life EDU, which has an anti-hazing component. The Executive Council has tied this Greek Life EDU component to each chapter's social privileges; new members and active members must complete the program for the chapter to be accredited. This new benchmark established by the EC guarantees each member of our organization has this training reinforced annually.

The Executive Council has also restructured our staff, which will allow our Educational Leadership Consultants to spend more time at each chapter. Our ELCs do in-person FIPG/anti-hazing training at each chapter. Also, each chapter may request additional risk management presentations in order to receive discounts on their risk management premiums, and many chapters are taking advantage of this opportunity.

The Executive Council has mandated that each member and new member sign an anti-hazing contract with the Fraternity. If a member violates this contract, they can be immediately removed from the chapter.

Finally, the Woodrow Wilson Leadership School held in Omaha, Nebraska had a greatly enhanced programming portion to teach the leaders of our chapters best practices for improvement. The WWLS had two separate anti-hazing sessions, where the VGPs of each chapter were taught how to deal with hazing issues, and instructed about the resources the fraternity has to help them address any potential problems.

Will these measures stop hazing? No. These measures are merely part of a wider risk management effort, which need to be put into the political and risk management

perspective of our host institutions and the Fraternity as a whole.

Our host institutions are increasingly taking a zero-tolerance policy towards fraternities. They suspend and remove first, and investigate second. We have seen this repeatedly play out across the country. Our chapters are put into a position of proving themselves innocent and not the universities or courts proving them guilty.

Sigma Alpha Epsilon and Sigma Phi Epsilon have wholly ended their pledge programs in an effort to stop hazing. My crystal ball says: insurance carriers are eventually going to mandate that for all Greek organizations.

So, where does this leave us? The answer is simple. Stop hazing. As alumni, if you are at the chapter facilitating such activities, stop it. Do not encourage hazing. Do not regale the undergraduates with tales of 'back in my day'. All too often when I speak with an undergraduate member about hazing, they say, "...you don't understand; it's the culture of our chapter." As alumni, we have an obligation to disrupt that culture and influence our men in a more positive way. Instead of telling them how you used to do it, show up and help with their philanthropy project or teach them how to develop brotherhood in a healthy way.

To the leaders of our chapters, I beg you, if someone wants to do a line-up: don't. If someone wants to go for a jog at 3:00am: don't. If you have someone in your chapter who insists on hazing, get rid of them. If you see it, please report it. The fraternity does not want or need members who haze.

Finally, to drive this point further home, I want to articulate the risk management position of the Fraternity. We have insurance and our insurance covers the Fraternity. Our insurance covers the chapter. Our policy DOES NOT cover our members. If you haze, you are on your own. You will have to explain to your parents why you locked someone in a dog cage. Phi Kappa Psi will not help you to defend your hazing; we will help law enforcement criminally prosecute you.

Phi Kappa Psi has an anti-hazing policy that goes back 148 years and our members are instructed on that position early and often, including the consequences of those violations. Any of our members who engage in any hazing activity does so out of pure defiance of our policy and not ignorance of it.

# DEPAUW CELEBRATES 150<sup>TH</sup> ANNIVERSARY



The Indiana Alpha chapter (*DePauw*) celebrated its 150<sup>th</sup> anniversary this past summer during the annual alumni weekend in Greencastle, IN. The celebration brought over 200 Indiana Alpha alumni and undergraduates together for multiple events during the June 6<sup>th</sup> weekend and it was a major success.

Indiana Alpha was chartered in January of 1865 and has remained active since that time. It has initiated over 2200 Phi Psis and remains the fourth oldest uninterrupted Phi Psi chapter. The anniversary celebration sparked major interest to celebrate and bring alumni of all ages back to the Rockpile. That chapter house, nicknamed 'The Rockpile,' refers to the existing chapter house built in 1926, which still stands today. The current chapter house replaced an old wooden structure that burned down in the early 1920's.

The weekend began on Friday in Indianapolis with a golf scramble at Brickyard Crossing Championship Course, followed by cocktails and dinner downtown at the Omni Hotel. Over 50 members attended Friday's events. Saturday began informally with many alumni gathering at the Rockpile

to celebrate their respective class anniversaries. The weather was beautiful and it set the stage for brothers to gather, tell stories, play yard games, and participate in a formal ceremony that included over 180 registered alumni. And, of course, there was a delicious catered dinner followed by live music that attracted many other DePauw alumni celebrating on campus to the front lawn of the Rockpile.

Highlights of the evening included a special dedication of the new Phi Psi Street Clock, speakers representing every decade since the 1950s, current chapter updates from both alumni and undergraduate leaders, recognition of Dorothy "Mom" Brown for her continued role as House Director, and the remembrance of a recently deceased chapter brother, Jim Barrett, who passed away shortly before the anniversary. The recent death and upcoming anniversary gave many alumni the opportunity to honor Jim's memory.

Jim Barrett, who succumbed to bone cancer this past March, was very active at DePauw during his undergraduate years and took on many Phi Psi chapter and student government positions during his time at DePauw. Famous



for his athletic abilities, Jim captained many intramural teams but was best known for his basketball skills. In honor of Jim, the class of '79 started a fundraising campaign during the Sesquicentennial celebration in Jim's name. After discussing a number of options on how the money raised could be used, the class decided to leave the decision up to his family. At the request of his wife Beth and his two children, the House Corporation has agreed to honor Jim by dedicating the new Phi Psi basketball court in his name. The project to overhaul the existing court will begin in the spring of 2016.

Another contribution from alumni to commemorate this anniversary is the new Phi Psi Street Clock. The street clock was given, not only to commemorate Phi Psi's 150 years on the DePauw campus, but to act as a 'gift' of sorts to the University, enhancing the Burkhart walkway. Phi Psis who excelled nationwide and/or have played a significant role in making DePauw a better place are engraved on the clock. One example is Ford Frick, former President and Commissioner of Major League Baseball.

During the dinner, a panel of brothers took some time to address the congregation about their Phi Psi experience and how it played a role in their own lives. Those who spoke included John Mote '50, Bruce Walker '53, Jim Taylor '67, Matt Neff '77, Scott Ullem '89, and Paul Mpistolarides '14. They talked about what the world was like during their college years and about the culture and environment of Phi Psi at DePauw. The stories they told left the audience smiling, laughing, and reminiscing on their own college years.

Of course, no Indiana Alpha gathering would be



worthwhile without honoring its housemother who, for these past 23 years, has been Dorothy Brown. As per tradition, the walk into dinner that evening began with two brothers escorting Mom Brown to her table, a tradition that still exists during chapter house lunches and dinners today. To commemorate her work and dedication to the Rockpile, alumni found it fitting to name the current dining room *The Dorothy "Mom" Brown Dining Hall*. Mom Brown was very gracious as always for this wonderful honor. As every Indiana Alpha brother knows, the DePauw Phi Psi experience would not be the same without wonderful housemothers such as Mom Brown. ■

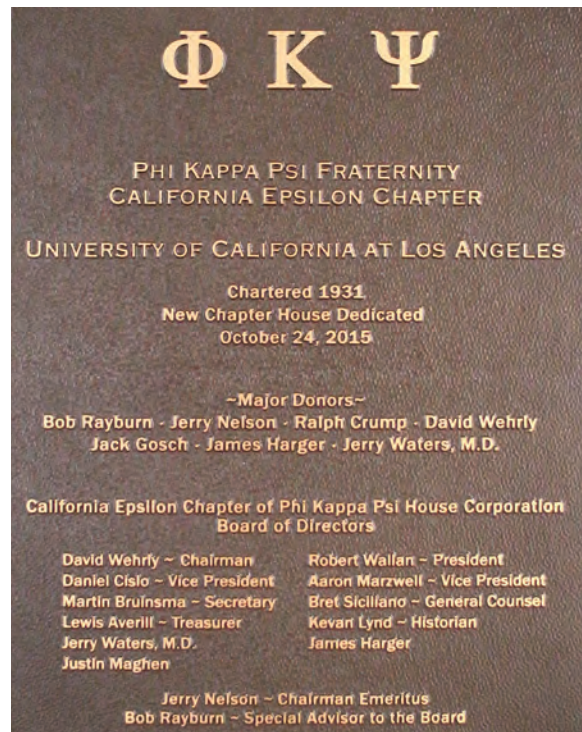

from influential donors such as Jerry Nelson (UCLA '48), Bob Rayburn (UCLA '92) and Dave Wehrly (UCLA '82), Brother SWVGP Jim Boyle (Washington '88) announced the UCLA colony petition has been approved by the Executive Council. **The UCLA charter will be re-installed on January 30, 2016.** Chapter President-elect Andrew Avila stated, "When Brother Boyle announced that our petition for charter was approved, the happiness that pervaded the room was incredible."

The 64 members of the UCLA colony have been thriving. 21 of those new members are the result of a successful fall 2015 recruitment. The new house, which is one of the most up-to-date Phi Psi houses in the country, has become a place for alumni and undergraduates to connect and perpetuate the goals of the Fraternity.

However, the house is not entirely paid off. A more than two million dollar mortgage still exists on the property. "It was great to honor the alumni that have dedicated their time and money, but we still have a mortgage towards the house to pay," said Brother Nelson, Phi Kappa Psi Foundation Trustee. "I encourage you to give what you can. Remember, you make a living by what you get, but you make a life by what you give." It's important to note that all of this wouldn't have been possible without the Phi Kappa Psi Foundation collecting tax deductible gifts from alumni, which allowed for grants to be made to the House Corporation.

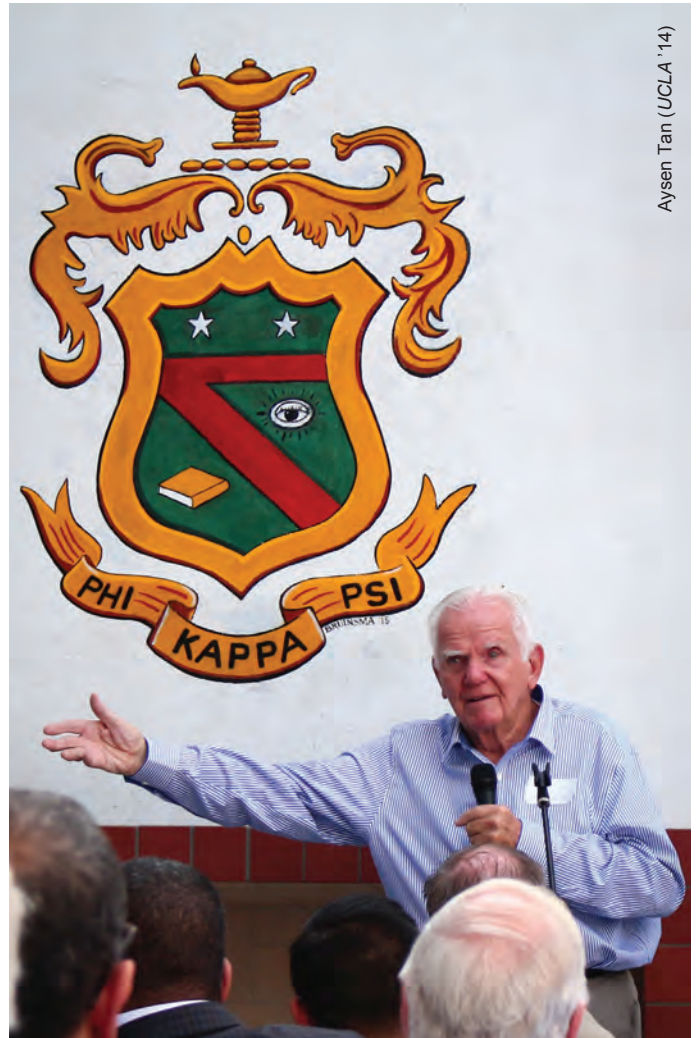

# NEPAL DECIMATED BY EARTHQUAKE – A PHI PSI STEPS IN TO PROVIDE SUPPORT

In April 2015, Nepal was hit by a magnitude 7.8 earthquake that shook the very foundation of its infrastructure... and a Phi Psi was there to witness the entire situation unfold.

Brother John Mead (*Tennessee '87*), former Deputy Attorney General of the Fraternity and Indianapolis, Indiana resident, was in Nepal when the earthquake hit. He was traveling alongside five friends (David Carter, Chuck Hasbrook, Glenn Moelling, Mike Myers, and Ace Yakey), 5 other American travelers, four Sherpa guides, and two Sherpa porters. The group was in the middle of a hiking trip to Mt. Everest Base Camp.

"You find wisdom when you go to Everest. An average trek to Everest Base camp, from door-to-door starting in Indianapolis, is 18-21 days," said Carter.

The entire trip changed after the 45-second earthquake unexpectedly hit the region. Mead and company struggled to make sense of the situation. They heard what appeared to be massive rockslides occurring off in the distance, which helped them recognize the severity of the situation. Quickly, the group diverted from their original path to return to the village of Lukla to avoid any additional calamity from the earthquake. Along the eight-day journey through countryside trails, the group dealt with several aftershocks which registered magnitude 6.0 and saw evidence all over the region exhibiting the level of devastation present. Although tragedy had shocked the countryside, all three men were able to escape unscathed and return to the United States.

"It's still part of your psyche to have been through that kind of experience; live through it, see the devastation that it causes and then leave, knowing you're leaving that devastation behind. I think that's something that stays with you," said Yakey.

Driven by an obligation to continue fighting for the people of Nepal, Carter and two others from the original trip returned to Nepal in June 2015. During that trip, more than 45 duffel bags of medical supplies, tents, tarps and solar chargers were delivered to people in need. The men also donated the money needed to rebuild some of the local infrastructure (especially in the village of Chyangba). In some areas, entire residences were wiped out by the earthquake

and the money funded the rebuilding of those homes. Despite the assistance rendered on the return trip, Carter, Mead and Yakey recognized making a long-term impact would require more than one visit and a small lump sum of cash.

"Over a million kids were school-less due to the earthquake," said Yakey.

In the following weeks, they worked closely with the Central Indiana Community Foundation to establish the Nepal Relief Fund. Since the development of the Fund, they have raised more than \$35,000 for the cause, but there is much more to do.

"We are on a mission to raise \$100,000 to build and support seismic safe schools, water systems, medical clinics, and infrastructure projects in Nepal," said Mead.

## TERRY HITCHCOCK (BOWLING GREEN '66) RUNS FOR SINGLE PARENTS, INSPIRES ALL



Brother Terry Hitchcock is quite an accomplished Phi Psi. He is an author, entrepreneur, teacher, activist and business consultant. He often speaks to various audiences with a unique, passionate and heartfelt style of communicating. Hitchcock reaches people from all walks of life with the same enthusiasm, portraying the human spirit that comes from his personal experiences of adversity and triumph.

In addition to motivational speaking, Hitchcock has authored and co-authored several books, including *American Business: The Last Hurrah?* and *A Father's Odyssey*, the latter now read in 27 counties and the inspiration of two films.

**My Run**, narrated by Billy Bob Thornton is a 2009 Indiewood Pictures production, receiving awards and acclaim. The second film, **Pushing Life** is a feature-length film still in production, and is expected to be released in 2016.

Hitchcock is also a veteran of the United States Air Force and member of Trust Vets, a founding member of the Founders' Bible Club, and helped establish National Grandparent's Day. He also received the Distinguished Medal of Merit and American flag from President Ronald Reagan and was invited to the White House by President Bill Clinton to promote child safety.

Many have dubbed Hitchcock as "The real-life Forrest Gump" after he ran the equivalent of 75 marathons in 75 days to honor kids and single parents. In all, he traveled more than 2,100 miles to arrive at the 1996 Summer Olympics Opening Ceremony in Atlanta. To honor veterans, he ran 60 miles across the Mohave Desert, proving nothing is impossible.

Hitchcock most recently spoke at the 2016 Terrence G. Harper President's Leadership Academy. He spoke to the Presidents to motivate them to turn their passion for Phi Psi into the energy needed to lead a chapter.

## DAVID L. HOOF (CORNELL '65) PUBLISHES ANOTHER NOVEL



David L. Hoof, New York Alpha '68 last wrote a book *Demythologizing Michael Phelps*, which established Brother Mark Spitz's Munich performance superior to Phelps, providing reasons, times and schedules. It was the book of the day in New Zealand on October 28, 2014.

His next novel, *A Death in Munich*, takes him back to Munich in a quite different way. It's a historical thriller based on an attempt by clandestine agents of Germany's Weimar government to topple the rising Adolf Hitler by involving him in a scandalous murder.

On September 18, 1931, Hitler's niece and live-in lover Geli Raubal was found dead by gunshot wound in a locked room in Hitler's Munich flat. The gun was Hitler's own Walther 6.35 mm revolver. The death was ruled suicide and Geli's body spirited across the border for burial in a Catholic cemetery in Vienna. But suicides are forbidden Catholic burials. Nor was this the only problem. An avalanche of contradictions tumbled out of police reports. Game on.

While the Weimar agents are hunting the murderer, Himmler's SS shoulder through the crowded streets of Oktoberfest hunting the agents. True in every detail to the facts that have emerged, the relentless hunt heats up in a crucible of unrelenting tension and betrayal. Never is the protagonist entirely free of danger. The murdered is not revealed until the last scene of the last chapter.

The book itself is a vehicle for time travel, constructed of materials, papers, photos, font styles and chapter formats used in Germany in 1931. As e books did not exist in 1931, there will be no e-book.

# A GREAT SMILE AND A STRONG HANDSHAKE

The U.S. Chief of Protocol position is a job title many people have likely never heard of before, but it is one of the most important jobs in the Executive Branch. Before the president meets any foreign dignitaries for critical diplomatic conversations, Selfridge is the first

to greet them upon their arrival and introduces them to Washington, D.C. A few examples of influential figures who Selfridge has debriefed include the Pope and the President of China. It is obviously a job that has a lot of pressure, necessitating months of planning and coordination. Not to mention, when you're the first person to meet such important visitors, you have to look the part; a professional look is expected and required.

In addition to being responsible for greeting dignitaries, Selfridge is in charge of a 70-person staff within the State Department, helping to ensure that all visits go smoothly. Luckily, Selfridge and his department has not been the subject of articles highlighting any mistakes or meetings that went wrong. Instead, Selfridge has hardly been noticed by anyone, even though he spends much of his time with dignitaries in the proverbial spotlight.

Selfridge has been very successful and he has even become close with President Obama. Selfridge is actually a regular golf partner with President Obama; a testament to his hard-work paying off.

Ambassador Peter Selfridge has played a direct role in helping the United States maintain relations with a varying degree of important dignitaries. As a result, Selfridge has been active in living the values of Phi Kappa Psi post-graduation. 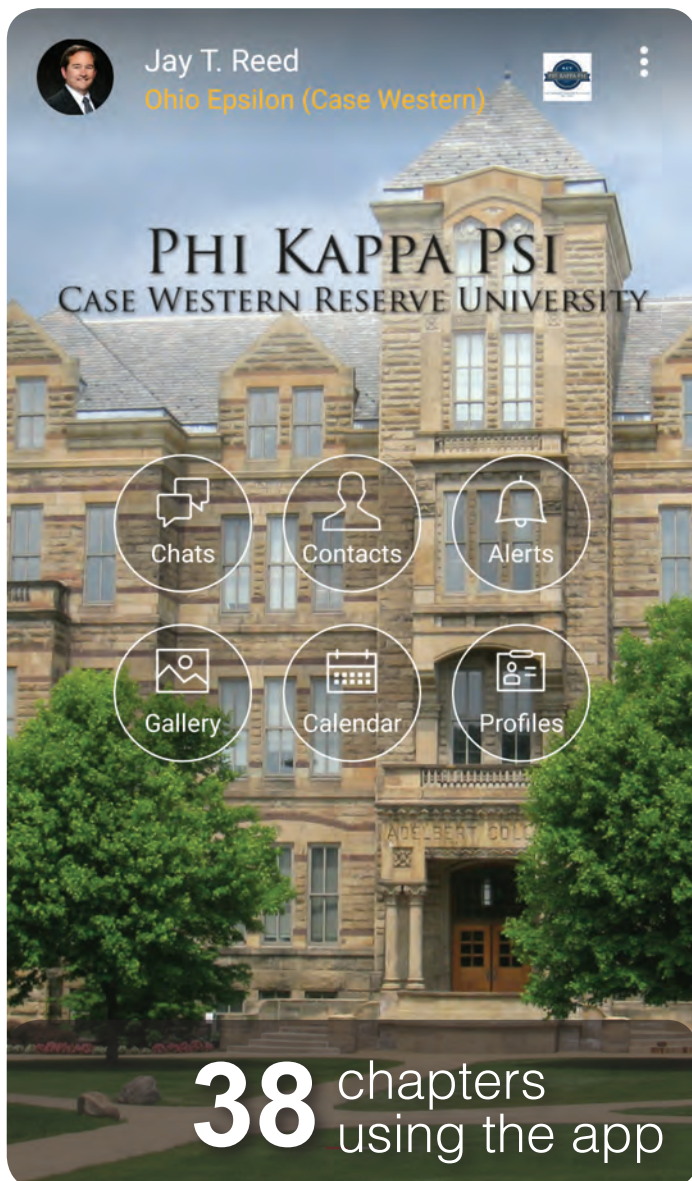

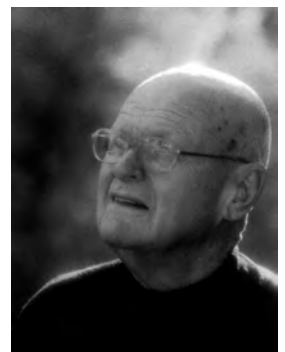


### **Dr. Charles E. Larsen**

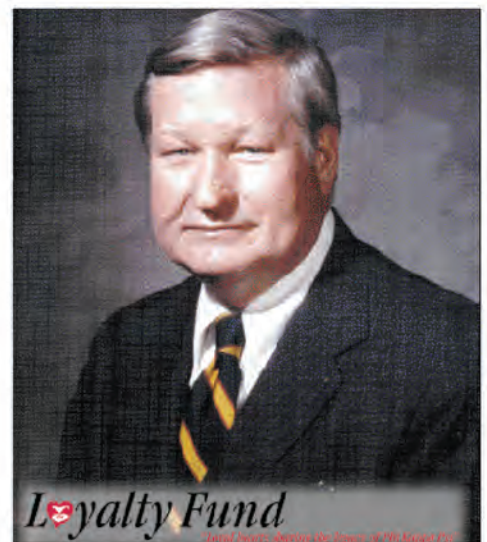

## FROM THE ARCHIVES



Taken directly from the transcription on the back of the nearly 3 foot square framed piece, this unique and large replica badge, hand-made out of silk comes with quite the story.

"This insignia was executed in 1902, in Japan, by a native of that country, working only from a small shield on a letter-head for Lawrence B. Dashill, of the U.S. Battleship Kentucky, as a surprise gift to his Brother, Howard N. Dashill of the Indiana Delta Chapter.

In collaboration with Brother John L. Porter (*Allegheny* 1886) Brother Dashill had it mounted and presented it, on Founders Day 1934, to the Pittsburgh Alumni Association of Phi Kappa Psi, which in turn presented it to the Executive Council of the Fraternity, through Brother C. F. "Dab" Williams (*Illinois* 1906) the Secretary of the Council.
